This course is for workers from transport, retail, wholesale, warehousing, etc, who require licensing under Motor Vehicle Legislation.

On completion of this course, you are eligible to apply for your NT issued driver licence to be upgraded to an LR driver licence (subject to MVR requirements).

This Course has a Licensing outcome

To be eligible to qualify for an LR endorsed driver licensing outcome, you must:

1. Reside in the NT
2. For LR - Have held a 'C' class driver licence for not less than 12 months
3. Your licence must be converted to NT issue before it can be upgraded

### Course Information

This course is conducted in the following format:

1. 40 minute Intake for enrolment, a theory session and assessment. Where the applicant requires, the theory training may be picked up from our office, delivered by post or email.
2. 3-4 hours of practical training conducted as required and booked by the applicant
3. Practical assessment is conducted by a NATA assessor in a 45 minute session

The course will be delivered at NATA's course delivery sites, or another suitable location as arranged with you or your employer. All required learning and assessment materials are supplied.

All practical training is one to one. Course intake numbers are limited to a maximum of 6 applicants.

## Course Details

The cost for the course is **\$500.00, GST exempt** (where eligible). Where you supply a vehicle of class LR, cost is **\$360.00**. Trucks must be loaded to 75% GVM, LR buses need not be loaded.

### Intake and Theory Test

**Start at 8am, finish by 8.40pm**

You will learn about the basics of vehicle control and operation, engine management, load restraint and fatigue management. The assessment is to be attempted before Intake, simply pick up your driver manual and assessment at the NATA office or request PDFs for printing.

### Practical Training

Your course fee includes up to **three hours** of practical training. You can book times for practical training with the NATA office or with your trainer and assessor. If you need extra practical sessions, these may be booked for **\$110.00** per hour.

*If your trainer and assessor believes you have are **fatigued**, or have **drugs or alcohol** in your system, you will be asked to show cause why you should continue your lesson. You may be asked to reschedule, this may be at extra cost to you.*

## Assessment Information

### Theory

You will answer 23 questions during your own time or at Intake, the test is open book.

### Practical

This assessment takes about 45 minutes and requires driving a set route and performing a set of tasks as specified under MVR and unit of competency packaging rules.

## Statement of Attainment

On achieving competency, you will be issued with a Statement of Attainment. You must provide, or allow NATA ability to create and/or search for, your valid Unique Student Identifier (USI). For further information, see [www.usi.gov.au](http://www.usi.gov.au)

## Licensing Information

To be issued with your licence, you will need to present your MVR Test and Statement of Attainment within 12 months from date of issue to the NT Motor Vehicle Registry (MVR), phone **1300 654 628** for locations. MVR will charge \$6.00 to endorse your licence.

## Payment

Payment of **\$500.00** (or **\$360.00** with own vehicle) for intake, training and theory assessment is required before commencement of the course. A **\$200.00** fee may apply where re-assessment is necessary.
