On completion of this course, you are eligible to apply for your NT issued driver licence to be upgraded to an HC driver licence (subject to MVR requirements).

### This Course has a Licensing outcome

To be eligible to qualify for a heavy rigid vehicle driver licensing outcome, you must:

1. Reside in the NT
2. Have held a MR or HR class driver licence for at least 12 months
3. Your licence must be converted to NT issue before it can be upgraded

Note that your licence endorsement for HC/MC is based on your HR licence.

### Course Information

This course is conducted in the following format:

1. a first day intake for a theory session and assessment
2. up to 8 hours (HR upgrade) or 10 hours (MR upgrade) of practical training is included, conducted in sessions as required and booked by the licence applicant
3. practical assessment is conducted by NATA's assessor over 1 hour 30 minutes and is recorded for MVR audit purposes

The course will be delivered at NATA's course delivery site, or another suitable location, eg. as arranged with your employer. All required learning and assessment materials are supplied.

All practical training is one to one. Course Intake numbers are limited to a maximum of 6 licence applicants.

## Course Details

The course is GST exempt (where eligible).  
Costs are:

- **\$1,700.00** (MR upgrade auto)
- **\$2,150.00** (MR upgrade 18 speed)
- **\$1,400.00** (HR upgrade auto)
- **\$1,850.00** (HR upgrade 18 speed)

Where your loaded vehicle is used, cost is:

- **\$1,550.00** (MR upgrade auto)
- **\$2,000.00** (MR upgrade 18 sp)
- **\$1,250.00** (HR upgrade auto)
- **\$1,700.00** (HR upgrade 18 sp)

Trucks must be loaded with trailers to 75% GVM. Where your prime mover is used, our loaded trailer may be hired for **\$275.00 (GST inc.)**.

### Intake and Theory Test

**Start at 8am, finish by 10am**

You will learn about the basics of vehicle control and operation, engine management, load restraint and fatigue management. The assessment is to be attempted before Intake, simply pick up your driver manual and assessment at the NATA office.

## Practical Training

Your course fee includes up to **10 (MR-HC) or 8 (HR-HC) hours** of practical training. You can book times for practical training with the NATA office or with your trainer and assessor. If you need extra practical sessions, they may be booked for **\$220.00** per hour (GST inc.).

### Assessment Information

#### Theory

You will answer 25 questions during your own time or at Intake, the test is open book.

#### Practical

This assessment takes about 1 hour 30 mins and requires driving of a set route, and performing a set of tasks as required under MVR and unit of competency packaging rules.

*Note: When driving an HC class heavy vehicle, you must be **drug and alcohol free**. If your trainer and assessor believes you are **fatigued**, or have drugs or alcohol in your system, you will be asked to show cause why you should continue your lesson. You may be asked to reschedule, this may be at extra cost to you.*

### Statement of Attainment

On achieving competency, you will be issued with a Statement of Attainment. You must provide, or allow NATA to create and/or search for, your valid Unique Student Identifier (USI). More information is at [www.usi.gov.au](http://www.usi.gov.au)

## Licensing Information

For your licence upgrade, you will need to present your MVR Test and Statement of Attainment within 12 months from date of issue to the NT Motor Vehicle Registry (MVR), phone **1300 654 628** for locations. MVR will charge **\$6.00** to upgrade your licence.

### Payment

Payment of **50% of course cost**, plus any hire fees, is required before commencement of your course.

The balance of your account is due after your assessment. A **\$650.00** fee applies where re-assessment is necessary.
